In approving transfers, the Superintendent or designee shall consider availability of space and instructional staff and the student's disciplinary history, academic records, and attendance records.

*The student's parent or other person having lawful control of the student, _____
(parent) requests that the student be permitted to attend Palacios ISD schools in the 2024—2025 school year and agrees to the following terms and conditions for that transfer:

***Transfer applications are considered on an individual basis without regard to sex, race, national origin, religion, disability, or ancestral language. In making transfer decisions, the District may consider grades, achievement test scores, attendance, disciplinary history, class sizes, available resources, and any potential adverse effect on resident students.**

1. This transfer is effective for the current school year only. District approval of this transfer creates no right or expectation that the student will be admitted as a transfer for any subsequent school year.
2. This transfer is approved for the named student only. District approval of this transfer creates no right or expectation that another student from the same family will be admitted as a transfer.
3. The student must maintain acceptable levels of attendance and academic standards, and compliance with District rules and regulations, including the Student Code of Conduct, throughout the entire school year. Failure to do so may result in revocation of the student's conditional transfer. Acceptable levels are defined as:
 - a. Attendance must not fall below 95% for the year. This 95% standard will be calculated at the end of the first semester, 3rd 9 weeks, and at the end of the year;
 - b. Compliance with any and all of the District's rules and regulations, including the Student Code of Conduct. This Agreement supersedes procedures, consequences, and due process for student discipline contained in District policies, procedures, and the Student Code of Conduct;
 - c. Acceptable minimum academic standards that do not inhibit progress towards grade advancement.
4. In accordance with Board policy FDA (Local), the Superintendent may revoke at any time, the transfer of a student who fails to maintain an acceptable level of attendance, a level of academic standards, or compliance with District rules and regulations, including the Student Code of Conduct. Parents will be notified in writing of any revocation.
5. Although the district may, at its sole option, establish and provide transportation for transfer students at certain designated locations, the parent of the student will ultimately be responsible for transportation to and from the District school to which the student is assigned.
6. The student and parent acknowledge the eligibility of transfer students for participation in any UIL activity or other activities governed by UIL rules and regulations will be determined in accordance with UIL rules and regulations.
7. The parent agrees that, in the event of revocation, the student will be immediately enrolled in the district of residence, another public school, a private school, or homeschooled to meet the curriculum requirements of state law.
8. In the event of approval of transfer, the transfer is approved for the named student only. District approval of this transfer creates no right or expectation that another student from the same family will be admitted as a transfer.
9. This agreement does not create any property interest in favor of the student in becoming or remaining enrolled in any District school. This agreement does not create any enforceable interest beyond its termination or revocation.
10. Except as modified by this transfer agreement, the student will be subject to all policies, regulations, rights, privileges, and responsibilities of enrollment in the District as if he or she resided in the District.

By signing this document, the Parent acknowledges and agrees to the above requirements and considerations related to enrollment and attendance at the District. The District and the parent agree that this transfer agreement is the entire agreement controlling the admission and enrollment of the student in the District for the 2024-2025 school year.
